Check-in will begin at 8:30am on Saturday, April 19th in Jamesville in the parking lot of River's Edge Restaurant (located next to Cypress Grill). Go to Jamesville on Highway 64 East and turn left into town at main intersection. When the road dead ends, turn right and you will see Cypress Grill and River's Edge on your left.

Route A – Leaving River's Edge at 9am – stopping for lunch on Bear Run Camping Platform, ending up at Town of Plymouth Access (beyond Weyerhauser) – entire trip will be on the Roanoke River – ferrying back to your car in Jamesville will be provided! (see maps on www.roanokeriverpartners.org)

Route B – (for more experienced paddlers) Leaving River's Edge at 9am – stopping for lunch at Cow Creek Camping Platform, cutting back through Broad Creek and Cut Cypress Creek and then hitting Roanoke River again for paddle back to River's Edge (see maps on www.roanokeriverpartners.org)

Part A – Photo/Model Release

I hereby waive any right to inspect or approve the finished photograph or advertising copy or printed matter that may be used in conjunction therewith or to the eventual use that it might be applied. I understand that there will be no compensation for the use of my photo or photos.

I hereby release, discharge and agree to save harmless the photographer, his representatives, assigns, employees from any liability as a result of any distortion, blurring or alteration, optical illusion or use in composite form, either intentionally or otherwise, that may occur or be produced in the taking, processing or reproduction of the finished product, publication or distribution of the same, even should the same subject me to ridicule, scandal, reproach, scorn or indignity.

Part B – Release and Waiver of Liability and Indemnity Agreement

I hereby release, waive, discharge and indemnify the Roanoke River Partners, the Martin County Tourism Development Authority and the Roanoke Paddle Club, the owners of all property used in the event, volunteers offering ferrying from egress back to access points, and all other volunteers and save them harmless from and against any and all claims, damages, liability, costs and expenses in connection with loss of life, personal injury, and/or damage to property arising from or out of any occurrence associated with participating in or observing Paddle Days 2008.

I expressly acknowledge and agree that the activities at Paddle Days 2008 by their nature are dangerous and involve the risk of serious injury and/or death and/or property damage. I further agree that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws governing the towns, cities, counties and states where this event is being conducted and that if any portion thereof is held as invalid, it is agreed that the balance shall continue in full legal force and effect.

I have read and voluntarily sign the release and waiver of liability and indemnity agreement and further state that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

This release, waiver and indemnification agreement specifically embraces each and every phase of the event sanctioned, authorized, offered and/or promoted by said releasees during the entire event and applies to every activity and/or service of the event and has the same effect as if executed after each and every activity of the event in which I am participating so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to the entire event.
